Learn about getting a waste tire storage permit



Oregon's waste tire program is designed to prevent problematic storage and disposal of tires by regulating how they are collected

and stored. It is also designed to encourage alternatives to disposal. Oregon law establishes a permitting system for waste tire carriers and storage sites, and also imposes a landfill ban on disposal of whole tires. If you store more than 100 waste tires at any one time, you must have a waste tire storage permit. (Click here for Oregon's waste tire administrative rules.)

Programs help connect youth with jobs



If you're looking to fill entry-level positions or are offering internship opportunities in Multnomah or Washington counties, read on.

Worksystems is a local non-profit that coordinates a regional system to deliver workforce development programs that help people get the skills, training and education they need to go to work or advance in their careers. Worksystems leverages funding from federal, state and local legislation, grants, as well as public and private sponsorships, to support a multitude of programs that successfully deliver a competitive youth and adult workforce system.

Two of its youth programs include "SummerWorks" and "Connect2Careers."

"SummerWorks" is a paid summer internship program that targets youth from diverse backgrounds ages 16-24 who have little or no work history. Youth complete a 10-12 hour "Work Readiness Training" that gets them the key soft skills they need to succeed at work, and then they apply to get matched with paid entry- and midlevel internship opportunities with local participating employers. The opportunity cost to sponsor one intern (180 hours of work) this year is \$3,250, which includes all wages, payroll processing, workers comp, employer of record services, youth job coaching, and other youth support services.

"Connect2Careers" similarly targets diverse youth ages 16-24 who have completed the 10-12 hour "Work Readiness Training." It provides a year-round, centralized portal for youth to search, get matched, and apply for paid direct-hire, entry level jobs with local companies.

There is no cost for employers to list their entry positions through the C2C job portal. Participating employers are committed to the value of the "Work Readiness Training," and are prepared to prioritize these youth in the application process.

Oregon dismantlers learn about new law



It was standing-room-only at the
October 8 NATA meeting for
Oregon dismantlers about
Senate Bill 792 and the impacts

it will have on all dismantlers in Oregon effective January 1, 2020.

Darryl Fuller, NATA's lobbyist, went through the bill and discussed the new rules that dismantlers must follow, such as: yearly fire inspections, a new bond amount of \$100,000, and a new required annual dismantlers certificate. DMV was assigned to oversee the rules of the bill, and Judith Moore and Larry Purdy from DMV were present to discuss their roles.

NATA is proud to be a part of the rewriting of this bill, which initially contained much harsher changes, but thanks to Fuller along with NATA's Board President Mary Ann Trout (of Hillsboro Auto Wrecking) and Jeff Helget (of B & R Auto Wrecking), the bill was adjusted to better fit the needs of dismantlers in Oregon.

At this meeting, Fuller handed out a "dismantler bond survey" which he asked all dismantlers to fill out return to him for feedback on the impact of the bond increase to \$100,000 from \$10,000.00. Facilitating "OregonSaves"



Oregon employers are required to facilitate "OregonSaves" if they don't offer an employer-sponsored

retirement plan. All eligible employers can join at any time prior to their registration deadline.

Those deadlines were last December 15 for businesses with 20-49 employees, last May 15 for those with 10-19 employees, this November 15 for those with 5-9 employees, and next May 15 for those with 0-4 employees.

If your deadline has passed, contact the OregonSaves Client Service Team at (844) 661-1256 to get started or to certify your exemption.

You'll be notified by OregonSaves when it's time for your business to register. You'll need two pieces of information before you begin:

- 1. Federal Employer Identification or Tax Identification Number (EIN/TIN)
- 2. OregonSaves access code from your notification

Do you already offer a plan? OregonSaves does not apply to employers who already offer an employer-sponsored retirement plan. If you received a notification OregonSaves, please <u>click here</u> to certify your exemption.
