#### CCC celebrates upgraded training facilities



More than 200 staff, students, elected officials and industry partners attended the January 31 grand opening of the new facilities that house the Automotive Service Technology and Autobody/Collision Repair & Refinishing Technology programs at Clackamas

Community College (CCC).

The \$6.8 million project, the fourth of five major projects on CCC campuses in Oregon City and Milwaukie, was funded by the passage of a 2014 bond measure in the Clackamas Community College district that provided \$90 million to expand labs and classrooms, as well as modernize equipment. Those funds were matched by \$32 million in state funds.

With an expansion of 12,600 square feet, the Automotive Technology program now has some 25,000 square feet of space that offers 23 service bays, 11 lifts (including two new Hunter alignment machines), four classrooms, along with new tools and equipment, instructor Rick Lockwood, a 15-year veteran at CCC, said.

"We would not have had this upgrade and expansion without the college administration pitching in to make it happen. We are very grateful to the administration and staff that helped us achieve the completion of this new space," he said.

The automotive program, which has three full-time instructors plus a part-time teacher, will likely add instructional staff as additional students enter training classes.

The automotive program works in conjunction with the World of Speed museum and area high schools to provide training both on campus and at the World of Speed facility in Wilsonville.

"With this new positive environment, we now need to move forward to help students pay for their education and tools so they can fill technician needs in industry," Lockwood said. "In order to do that we will be working closely with our industry partners that include dealerships and shops involved with the Northwest Automotive Trades Association (NATA). We've worked closely with Margaret Ragan at NATA and the programs they have sponsored to promote industry

partnership."

The Autobody/Collision & Refinishing Technology program at CCC also gained 9,000 square feet of space, added two new paint booths and a dual prep deck, said instructor Mark House, a graduate of the CCC autobody program who joined the teaching staff in 2000. With 14 service bays, he said the facility can handle up to 16 vehicles. Located just across a driveway from automotive technology, the program was previously housed in three buildings and had limited classroom and service space, he said.

During his presentation to open house attendees, House said the autobody program was one of 10 colleges in the nation to receive a \$100,000 grant from the All Within My Hands Foundation that was launched by the heavy-metal band Metallica. That was for the 2019 and another \$100,000 grant from Metallica has been awarded for 2020.

"It helped our 'heavy metal' students in automotive, welding, and manufacturing purchase tools, equipment, and textbooks," House said.

With 24 current students, House said both student enrollment and staff will be increased with the expansion of the autobody/collision training facility.

Dr. Tim Cook, CCC president, said the "state-of-the-art automotive programs meet the needs of local industry partners and we're excited to see this expansion of these in-demand training programs." In his address, Cook praised the major involvement of business partners who support CCC programs, sit on advisory boards, attend career fairs, and hire graduating students.

"This is education that works," he said.

# Consider how you write this year's date



We recently saw a caution against writing the date as, for example, "2/5/20," but rather write the year out in full as "2/5/2020."

The reason? If you just write

2/5/20, it could potentially be changed to "2/5/2021" or "2/5/2019."

If you agreed to begin making payments on 2/5/20, for example,

someone could claim that obligation began on 2/5/2019 and try to collect additional money.

A never-cashed check dated 2/5/20 could be changed to 2/5/2021, possibly making the uncashed check active again.

# Why your Oregon license may not fly...



As of October 1, your existing
Oregon license won't be sufficient
to board a flight at PDX. On that
date, the Transportation Security
Administration (TSA) begins
requiring a new type of
identification that is compliant with
the Real ID Act - something
Oregon licenses are not. Oregon

DMV will begin offering a Real ID option on July 6, but that won't allow enough time to issue the nearly 1 million new licenses for Oregonians prior to the October 1 deadline.

If you don't have a Real ID compliant form of ID at the airport, TSA will put you through an alternate identity verification process that could take an hour or more, and you could miss your flight.

One alternative: Obtain and use a passport or passport card. The cost of getting a new passport card is roughly equal to that of getting a replacement license with the Real ID option - and you can apply now at one of over 76 acceptance sites across Oregon.

# NATA member support helps veterans



A desperately-needed van to help transport veterans has been purchased for Veterans Village in Clackamas thanks to funds raised at the "Salute to Veterans Car & Motorcycle Show" in 2019. The generous support of NATA members and other sponsors of the event made possible the purchase of a 2013 7-passenger van with only 58,000 miles. Thanks, too, to Carr Subaru in Beaverton for helping with incredible pricing.

The newly-opened Veterans Village temporarily houses homeless veterans while helping them get on their feet. The village includes tiny houses (pods) with a central kitchen, bath and laundry facility, and also provide some services and resources. But because the facility is in a light industrial area, there is no public transportation nearby. So the van now enables transporting these veterans to additional needed services and appointments.



#### Programs help connect youth with jobs



If you're looking to fill entry-level positions or are offering internship opportunities in Multnomah or Washington counties, read on.

Worksystems is a local non-profit that coordinates a regional system to deliver workforce development programs that help people get the skills, training and education they need to go to work or advance in their careers. Worksystems leverages funding from federal, state and local legislation, grants, as well as public and private sponsorships, to support a multitude of programs that successfully deliver a competitive

youth and adult workforce system.

Two of its youth programs include "SummerWorks" and "Connect2Careers."

"SummerWorks" is a paid summer internship program that targets youth from diverse backgrounds ages 16-24 who have little or no work history. Youth complete a 10-12 hour "Work Readiness Training" that gets them the key soft skills they need to succeed at work, and then they apply to get matched with paid entry- and mid-level internship opportunities with local participating employers.

The opportunity cost to sponsor one intern (180 hours of work) this year is \$3,250, which includes all wages, payroll processing, workers comp, employer of record services, youth job coaching, and other youth support services.

"Connect2Careers" similarly targets diverse youth ages 16-24 who have completed the 10-12 hour "Work Readiness Training." It provides a year-round, centralized portal for youth to search, get matched, and apply for paid direct-hire, entry level jobs with local companies.

There is no cost for employers to list their entry positions through the C2C job portal. Participating employers are committed to the value of the "Work Readiness Training," and are prepared to prioritize these youth in the application process.

#### Oregon graduation rate hits record high



Oregon's high school graduation rate has hit an all-time high of 80%, meaning 600 more students graduated last year than the previous year.

"That's 600 more lives changed due to the efforts of Oregonians - from students and educators to advocates and legislators - working to ensure the

system works for every student," Toya Fick for Stand for Children wrote in an email to NATA. "We're proud, and you should be too because you helped make it happen. School districts across Oregon are crediting their graduation rate improvements to Measure 98 funding, which you helped make possible. Over the last two school years, Measure 98 provided over \$170 million to ensure more high school students are on a path to a brighter future. The climbing graduation rate is proof of their progress."
