Body shops have chance to 'grade' insurers

Collision repair professionals once again have a unique opportunity to grade the performance of the insurance companies in their state, with the launch of *CRASH Network's* "Insurer Report Card."

The "Insurer Report Card" each year asks collision repairers to grade each insurer based on how well each carriers' claims practices ensure quality repairs and customer service. By assigning insurers a grade from "A+" to an "F," shops can let consumers know which insurers have their eye on quality repairs and customer service - and which may have some room for improvement - when consumers have a claim.



It can be completed in less than three minutes (though shops are encouraged to spend time to explain why they gave each insurer the grade they did), and all individual shop identification information remains confidential. Shops that complete the "Insurer Report Card" and provide an e-mail address will be sent the results, at no charge, once they are compiled.

SAIF complying with state order in fire areas

On October 18, Oregon's Department of Consumer and Business Services [extended the emergency order](#) to address businesses affected by the wildfires. The order will be in force through November 16, and may be extended. It applies to [businesses located in zip codes designated by DCBS](#) to be

affected by the wildfires. This list of zip codes has been updated since the original order was issued.



The order addresses:

- Reporting requirements for claims. (Please note that employers are still required to file claims within 5 days of their notice or knowledge of a claim.)
- Grace periods for payment of insurance premiums and performance of other duties by policyholders
- Temporary postponement of cancellations and non-renewals

SAIF will comply with the requirements of the order and support our policyholders in the affected areas.

SAIF is committed to helping those who have been struggling because of the wildfires and the COVID-19 pandemic maintain their coverage. The industry lost a great, long-time supporter in early October when Al Stewart died at age 84. Many will remember him from his many years at Portland Transmission Warehouse (PTW), where he retired as general manager and vice president in 2011, and for



his presence at so many auto shows and rallies. But his love of cars began in his childhood, and after attending Lewis & Clark College, he moved to San Francisco to sell automotive parts for Wagner Company. In 1961, he returned to Portland to join Borg Warner, until forming his own company, the Stewart Group, as a manufacturer's representative. He joined PTW after several years.

He contributed his leadership skills to the industry, serving as president of the Oregon Automotive Parts Association and NATA.

ASE offers entry-level certification

The National Institute for Automotive Service Excellence (ASE) offers "Entry-Level certification," the first step in building career credentials as an automotive service professional.

"The ASE Entry-Level certification tests are designed to indicate a substantial level of practical, knowledge-based readiness for the workforce in those seeking a career in the automotive service industry," Mike Coley, ASE Education Foundation president, said. "These tests are intended for students in career and technical programs and are a predictable gauge for future success with ASE professional-level certifications."



Geared toward students completing a program of technical study, ASE Entry-Level certification tests are available for the automobile, collision repair/refinish and medium/heavy truck segments. The tests are designed and calibrated for those with no hands-on work experience. The certifications are good for two years.

"For students, ASE Entry-Level certification is a gateway to a professional automotive career and demonstrates to employers a potential to become a high-performing employee," Coley said. "For schools, these tests can also serve as an excellent metric for a training program's effectiveness, and for employers, this credential is way to evaluate the skills of entry-level student employees. We encourage all students to ask their instructors about ASE Entry-Level certifications and recommend that schools and employers contact the ASE Education Foundation if they need more information about the program."

Change could put more students in schools

A change in Oregon rules related to COVID-19 infections could allow an estimated 130,000 students to return to the classroom as early this month.

The new rules will move the focus to infection rates based on individual counties rather than any statewide measurement. While the majority of students in the state will likely be required to continue with distance learning, many could return to schools.
